## **Senator Bentz Assembles Team for 2019 Legislative Session**

SALEM--Senator Cliff Bentz (R-Ontario) has assembled the following people to help represent District 30's (Baker, Grant, Harney, Jefferson, Malheur, Wheeler, and parts of Clackamas, Deschutes, Lake, Marion, and Wasco Counties) interests during the 2019 Legislative Session, which will formally convene January 22, 2019. (Legislative process and work will actually begin on January 14th).

**Andrea Dominguez**, of Ontario, Oregon, is Senator Bentz's District Director. A member of Senator Bentz's staff since 2009, Mrs. Dominguez holds a Bachelor's degree in Media Arts with a concentration in Journalism from Eastern Oregon University, and an Associates' degree from Treasure Valley Community College.
