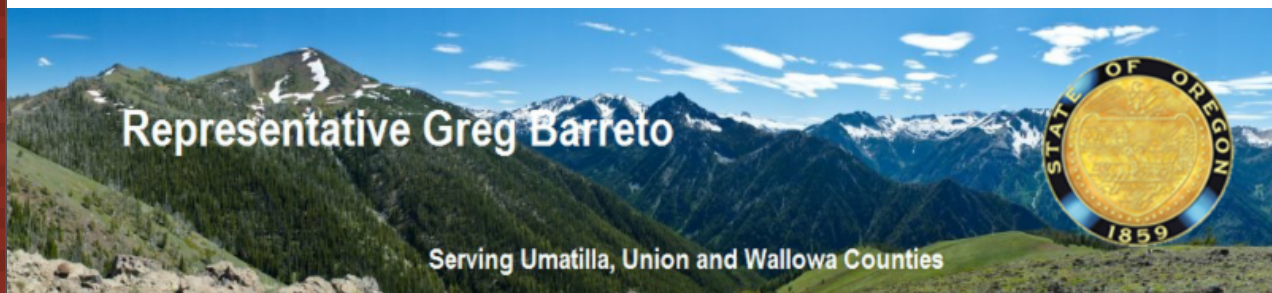

Action Alert

HB 3063 Vaccination Bill

Removes ability of parents to decline required immunizations

Vote occurring on Monday on House floor.

Contact your Representative if this bill affects you and your family.

Public Hearing

- [SB 370](#) A Requires employer to provide notice to employees of upcoming inspection by federal agency of employer's records regarding identity and employment eligibility of employees within three business days of employer's receipt of notice of inspection from agency.
- [SB 494](#) A Requires employers who are authorized to pay subminimum wages to individuals with disabilities to pay certain wage rates until June 30, 2023.

Work Session

- [SB 227](#) Authorizes cemetery authority, or person with authority to determine disposition of human remains, to move, temporarily store or reinter human remains dislodged from original cemetery plot by natural disaster or other similar emergency.
- [SB 272](#) Includes assistant attorneys general among public employees who are prohibited from striking.

- [SB 294](#) Authorizes annexation of land to pioneer cemetery maintenance district upon petition by owner and approval of governing body of district.
- [SB 298](#) A Allows employee or agent of funeral home or person acting as funeral service practitioner named in record of death or fetal death to request certified copy of record of death or fetal death at any time following date of death.
- [SB 519](#) A Increases minimum wage exemption for purposes of garnishment and execution.

- [SB 218](#) B Authorizes Oregon Liquor Control Commission to refuse to issue initial marijuana production licenses based on supply of and demand for marijuana.

Work Session

- [SB 590](#) A Conditionally limits space considered to be occupied by dealer for

purposes of obligation to redeem beverage containers.

- **SB 829** A Requires that, to extent provided by Oregon Liquor Control Commission rules, if appellation of origin on wine label is American viticultural area in Oregon that is in larger American viticultural area, label must also identify larger American viticultural area.
